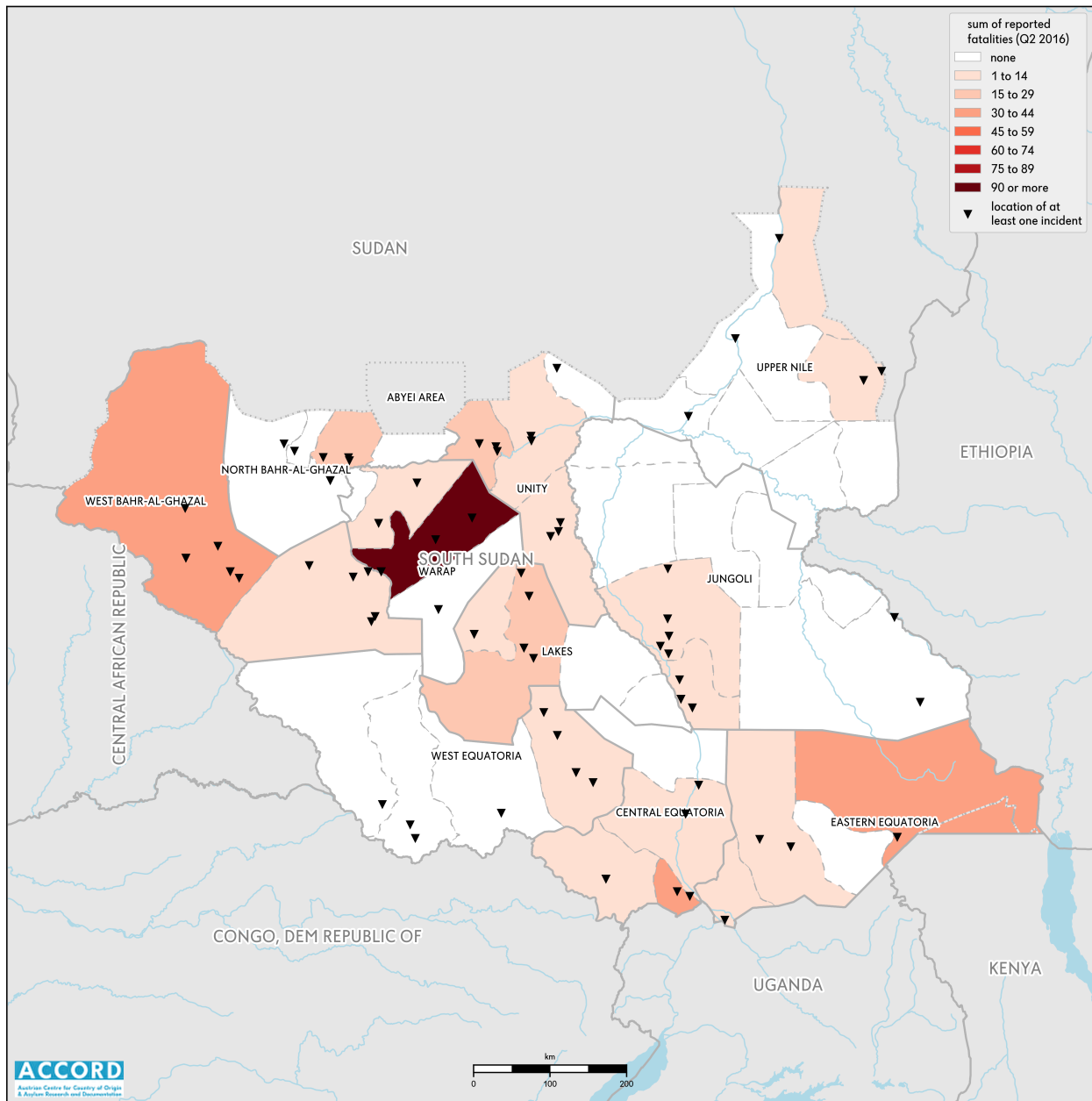


SOUTH SUDAN, SECOND QUARTER 2016:

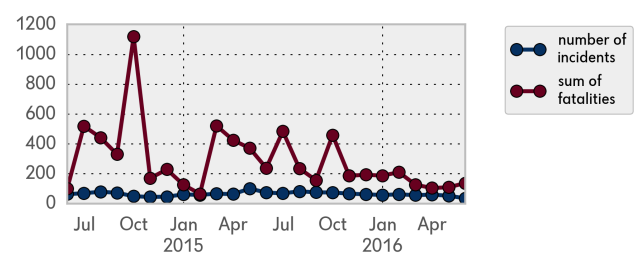

LOCALIZATION OF CONFLICT INCIDENTS

Note: The following list is an overview of the incident data included in the ACLED dataset. More details are available in the actual dataset (date, location data, event type, involved actors, information sources, etc.). In the following list, the names of event locations are taken from ACLED, while the administrative region names are taken from GADM data which serves as the basis for the map above. Data on incidents in the Abyei area are not reflected in this update.

In **Central Equatoria**, 27 incidents killing 62 people were reported. The following locations were affected: **Juba, Kajo-Keji, Kansuk, Mangalla, Yei.**

In **Eastern Equatoria**, 6 incidents killing 48 people were reported. The following locations were affected: **Hiyala, Narus, Nesitu, Nimule.**

In **Jungoli**, 16 incidents killing 6 people were reported. The following locations were affected: **Ajon, Boma, Bor, Duk Fadiat, Jalle, Kolnyang, Padak/baidit, Pakayr, Panyagor, Pochalla.**

In **Lakes**, 10 incidents killing 30 people were reported. The following locations were affected: **Maper, Marial, Ngong, Pacong, Rumbek.**

In **North Bahr-al-Ghazal**, 9 incidents killing 23 people were reported. The following locations were affected: **Aweil, Gok-machar, Maluakon, Malwal Dit, Nyamlell, Wanyjok.**

In **Unity**, 16 incidents killing 35 people were reported. The following locations were affected: **Bentiu, Bilthiang, Koda, Leer, Mayendit, Mayom, Rubkona, Rupchai, Yida.**

In **Upper Nile**, 7 incidents killing 4 people were reported. The following locations were affected: **Doro, Maban, Malakal, Melut, Wadakona.**

In **Warap**, 28 incidents killing 100 people were reported. The following locations were affected: **Akop, Kuajok, Majok, Tonj, Warrap, Wau.**

In **West Bahr-al-Ghazal**, 16 incidents killing 41 people were reported. The following locations were affected: **Abu Shakka, Bazia, Deim Zubeir, Gettan, Jabal Angunu, Khorr Ghana, Mangaia, Mboro, Raja, Sopo.**

In **West Equatoria**, 12 incidents killing 1 person were reported. The following locations were affected: **Bushayr, Diabio, Lanyi, Li Rangu, Mundri, Mvolo, Yambio, Yeri.**

METHODOLOGY

The data used in this report was collected by the Armed Conflict Location & Event Data Project (ACLED). ACLED collects data on reported conflict events in selected African and Asian countries, South Sudan being among them. ACLED researchers collect event data from a variety of sources and code them by date, location, agent, and event type. Based on these data, the Austrian Centre for Country of Origin & Asylum Research and Documentation (ACCORD) compiles updates on conflict incidents.

Incidents comprise the following categories: battle, headquarters or base established, non-violent strategic activities, riots/protests, violence against civilians, non-violent transfer of territory, remote violence. For details on these categories, please see

Fatality data particularly is vulnerable to bias and inaccurate reporting, and ACLED uses the most conservative estimate available. Furthermore, event data may be revised or complemented in future updates. The lack of information on an event in this report does not permit the inference that it did not take place.
